I. Call to Order

II. Greetings and Introductions: Corey Wilt, Acting Manager of the Local Management Board welcomed the group and all participants were introduced

III. Minutes- The November meeting minutes were approved.

IV. Meeting

A. FY20 application – We were notified on Friday that the application will no longer be competitive. Carroll County will receive funding through 2020. Each program will be scored and there will be no threshold based on the score. The application is simplified with no page limits. 3 new strategic goal areas have been added; diversion, out of home/state and trauma. The NOFA will be posted on the GOCCP website.

B. Program Presentations

a. Project Connect – two generation program serving parents, caregivers and children with an incarcerated family member. The program will use the Project SEEK model and includes home visits, connections to resources, parenting classes and support groups and facilitation of communication between incarcerated parents and their children.

- b. Customized Employment** – 18-21 year old youth with disabilities leaving the post-secondary program through CCPS, and are not employed and now working will be eligible to participate in customized employment services to engage in work or higher education.
- c. Family Ties** – Incarcerated parents and their children will be provided in person visits at the Visitation Center, pending participation in parenting classes, and approval from the warden. Incarcerated parents must be eligible for work release, participating in re-entry services, and participating in the Strengthening Families parenting classes to be eligible.
- d. Connecting Youth in Carroll** - Works with youth and young adults between the ages of sixteen and twenty-four who are not in school, not working, and who may be homeless
