D	Addition, Garages, Sheds, Alterations, Finished Basements, Electric Vehicle Chargers	\$60 – 1-50 outlets (\$85 with service upgrade) \$150 – Over 50 outlets with service upgrade
E	Hot Tubs Swimming Pools – bonding & wiring	\$50.00 \$120 bonding & wiring or \$60 each
F	Sub Panels	\$35.00 each
G	Service (new, upgrade or change), Meter, Equipment & Feeders, Generators,	\$60 – not over 400 amp \$100 – not over 600 amp \$130 – not over 1000 amp \$160 over 1000 amp
H	HVAC and Geothermal	\$60 new, \$35 replacement (prices are per system)

J	Water Heaters, Cooking equipment and other similar appliances	\$60 – Outlet for 1 unit 30 kw or less \$6 – Each additional unit 30 kw or less
K	Motors/Transformers, Electric Vehicle Chargers Central Heating & A/C Units, Furnaces, Welder	\$60 – each 1-5 \$5 for each additional over 5
L	Primary Transformers/Vaults/Enclosures/Sub-Stations/Switchboards	\$90 – Not over 200 KVA \$120 – 200-500 KVA \$170 – Over 500 KVA
M	Protective Signaling System	\$90 – First 15 devices \$6 – Each additional 5 devices
N	Service (new, upgrade or change), Meter, Equipment, Generators & Feeders Subpanels	\$60 – not over 400 amp \$100 – not over 600 amp \$35.00 each \$140 – not over 1000 amp \$170 over 1000 amp

Q	Ground Work for Footing/Foundation letter	\$60
R	Carnivals, Circus, etc.	\$100
S	Periodicals	\$220 – Day \$145 – Half Day \$70 – Hourly
T	Area Lighting	\$60 – First pole/unit \$10 – Each additional pole/unit
U	Re-Inspection Fee: Extra trip fees for things such as: premature inspection requests, incomplete work, and work areas not accessible.	\$50 – 1st Additional Inspection \$100 – Repeated Violation/Additional Inspections beyond 1st
V	Investigation Fee (Work Started Without Permits)	Double Permit Fees \$100 Working Without Permits, \$100 for each Missed Inspection, \$500 for repeat offenders
W	Change of Electrician	\$35 Plus the cost of a new electrical permit application
