K	Tenant Fit-Outs	* \$120 + **\$.10 per square foot + \$30.00 Use & Occupancy
L	Change of Use **	* \$120 + **\$.10 per square foot + \$30.00 Use & Occupancy
M	Change of License (Not associated with new construction. i.e. Beauty Salon, etc.)	* \$120 + \$50
N	Signs - On Building, Freestanding, Portable	* \$75 per side
O	Solar Panels/Wind Turbines	* \$120 + \$50
