General Public MS4 Workshop

The MS4 permit also requires implementation of the public education and outreach program to include information to the general public. The EAC developed and held an educational event. Homeowners were invited to attend to learn about practices they could implement at their own homes and properties to minimize runoff and prevent pollution. The EAC arranged logistics, advertised, and secured speakers and exhibitors.

This event was held on Saturday, March 18, 2017, in the Great Hall at Carroll Community College.



Eight different topics were addressed by individual speakers in break-out sessions

throughout the event, including Homeowner

BMPs, composting, lawn care and landscape maintenance, permeable pavement, rain gardens, recycling, septic maintenance, and tree planting. **COMPLETED**

Guide to Residential Solar Installation in Carroll County

As a follow-up to the amendments to the zoning code to allow solar facilities and to modify the size provisions in residential districts, the EAC prepared a public outreach piece to provide information to residents on the process to install solar facilities at their homes in Carroll County.

Each member of the EAC researched an aspect of solar installation and drafted associated text. The text was compiled, and the **EAC** members



individually and collectively reviewed and revised the draft.

The final text was formatted and finalized. The Board was briefed on the final booklet on October 19, 2017. The booklet is available on the EAC's

2017 Update to Environmental Stewardship in Carroll County

The Environmental Stewardship booklet, updated every other year beginning in 2015, is intended to showcase the great work that Carroll County is doing to demonstrate good environmental stewardship. The booklet was updated this year to reflect current information (as of end of FY 2017), and the following additional topics were added:

- Natural Resource Conservation Programs in which Carroll County farmers participate
- Watershed Restoration Plans
