Subject: DFEMS assignment of field operations / personnel mandatory holdover days

Date: July 1, 2023

In order to assure consistent delivery of quality emergency services in a timely and efficient manner, mandatory hold-over (MHO) days shall be assigned to all field personnel at and below the rank of Station Lieutenant. This will allow Carroll County and the Department of Fire & EMS the ability to maintain consistent staffing levels across the county.

This hold-over day will be on a rotating cycle based on the number of positions needed to appropriately staff the department each day. In order to maintain the depth of staffing needed to fill any potential vacancy, the hold-over list shall encompass all members of the shift. The hold-over list shall rotate each shift in a descending order. The hold-over position shown as #1 will move to the #2 position the next shift and continue until that position reaches the bottom of the list. The following shift that position will go to the top of the list with the rotation continuing in that manner.

The hold-over day is assignment to the staffing position and not the individual. Station Lieutenants shall be assigned a Lieutenant MHO, FADOs a FADO MHO, and so forth. In the event of transfers, the holdover day will be passed to the individual assuming that assignment and not follow any individual to their next assignment. As additional position are staffing across the department, additional hold-over positions will be added. An SOP will be forthcoming to formalize this process, but this will serve as the MHO policy in the interim.

When an MHO becomes necessary, the on-duty shift commander shall notify the station lieutenant who will then notify the impacted personnel. In the case of a station without an officer, the shift commander shall directly notify the impacted personnel. The availability of personnel to work overtime should limit the need to implement the MHO. It is our goal that the current hiring process can bring us to full staffing to include our float positions and further minimize the MHO. Please direct any concerns via your respective chain of command.
