**Subject:** 2024/2025 ALS Providers NCCP/ALS Skills

Any Career, County Volunteer or Corporate ALS Employee affiliated with Carroll County Department of Fire and EMS who possesses a National Registry Paramedic, or a Maryland CRT license or certificate may attend the following ALS continuing educations recertification. All career employees with a certification or license that are due to expire in 2025 are strongly encouraged to attend these recertification offerings. Carroll County has committed to compensating career employees for their recertification process if attending these in house offerings.

These sessions will cover the Department Core Content of the ALS Continuing Education Program and are specifically designed to meet the National Core Competencies Program (NCCP) requirements for recertification by the National Registry of Emergency Medical Technicians (NREMT). Anyone choosing to recertify through this offering will be required to attend four sessions. Failure to complete any portion of the program could jeopardize the clinician's ability to recertify in 2025.

Licensed, Non-functioning clinicians are welcome to attend any of the 2024/2025 ALS Continuing Education Program (based upon available seats). However, the Medical Director is not able to sign registry documents or acknowledge ALS affiliation for clinicians not currently functioning in Carroll County.

The 2024/2025 recertification will consist of four sessions which have been color coded in their schedules below for ease of use. Every ALS clinician regardless of need for recertification will complete the mandatory ALS skills session labeled in red on this document. ALS clinicians looking to recertify licenses expiring in 2025 must also attend three additional sessions, one from each of the blue, green, and purple schedules.

DATES FOR SESSION 2 AND SESSION 3 ARE TO BE DETERMINED – AN UPDATED SCHEDULE WILL BE SENT OUT WHEN AVAILABLE.
